



**PARKING LOT APPLICATION**

A limited number of assigned parking spaces will be available in the Bromley Hall parking lot for the Academic Year. Parking spaces will be allocated on a lottery basis. Spaces are \$700.00 for the Academic Year. Parking lot fees are **NON-REFUNDABLE** and cannot be assigned or transferred to anyone else. Please complete the following information and return it with your check for \$700.00 made payable to Bromley Hall to the Business Office **NO LATER THAN 10:00AM on MONDAY, AUGUST 27, 2018**. You will be notified via email if you have been assigned a parking space and a permit that will allow you to park in the lot. If Bromley Hall cannot provide you with a parking space, your original check will be returned.

**AGREEMENT**

I fully understand and agree that Bromley Hall is in no way responsible for any articles left in my car nor for any damages done to my car while it is parked in the Bromley Hall parking lot. I accept all risk for any damage to my vehicle. Furthermore, I agree not to resell or allow persons other than myself to park in Bromley Hall parking lot. It is further agreed that I will not use the parking lot for any unlawful purpose or for anything other than to park my vehicle. I also understand that this parking lot agreement remains in effect only while I reside at Bromley Hall. Should I cancel my Room and Board Agreement for any reason, I forfeit my parking spot and understand there will be no refund of any monies paid.

I agree to notify Bromley Hall in writing of any changes in vehicles, including the description as well as the license plate numbers for vehicles other than those indicated below. Failure to do so may result in the unidentified vehicle being towed away, in which event Bromley will not be responsible for returning the vehicle or paying any fines or charges for the towing. The Bromley Room and Board Agreement that I signed is incorporated herein by reference and any and all applicable provisions contained therein shall also apply in this instance.
